1.1 Purpose of policy:

The Waste Electrical & Electronic Equipment (WEE) Regulations aim to reduce the quantity of waste electrical and electronic equipment (WEE) incinerated or sent to landfill sites, and increase its reuse, recovery, and recycling.

Recycling and reusing unwanted electrical or electronics can help save the planet, boost the
economy, and improve lives. Not only that, electrical and electronic equipment (EEE) contains
materials, parts and substances which can be dangerous to the environment and harmful to human
health if not disposed of correctly.

1.2 Statement of intent:

To align with government regulations and SMI's adopted zero to landfill approach to waste. Extending beyond the waste generated at our head office and distribution center but ensuring our customers (business to business) can safely and securely recycle, recover, or repurpose their waste.

1.3: General Requirements:

When purchasing a new electrical, electronic or battery item from SMI, at the end of the product's life cycle you can contact your Customers Experience Specialist to arrange for this item to be collected for recycling. The items you wish to return and recycle do not have to have been originally purchased from us, but they must be of an equivalent like-for-like type and size to the new product you are buying. Once you have made your new purchase, please arrange for your old item with your receipt, sales order number or purchase order to hand and contact SMI.

Please make sure the item you are returning is clean and dry and does not represent a health or safety hazard when handling.

The below charges will be incurred by the customer:

1) An approximate cost of £9.95 collection fee will be incurred. *Please note the cost is subject to change.* (if you send this back by your own shipping method then this charge won't be added.)

1.5 What can I recycle?

Anything with a plug, battery or cable can be recycled or reused. The materials from recycled electricals can be used in everything from children's playgrounds to lifesaving equipment, while donated tech can help bridge the digital divide.
